## NARRATIVE

On the above listed date and time, Officer Mathiesen #1386 and I were in full police uniform driving a marked patrol vehicle when we responded to 185 Channel St #622 regarding a possible domestic violence incident.

While in route, the 911 caller (RP1) [REDACTED] advised us that she was able to hear what sounded like a heated argument along with the sounds of possible furniture thrown into the walls.

Upon arrival, [REDACTED] met Officer Mathiesen and me at the front door with a voice recording of what she described to the 911 dispatcher. [REDACTED] stated she obtained the recording by placing her cell phone to the door #622 where the sounds were emitting from. I listened to the recording and heard what appeared to be a female voice saying "stop, please stop" and the sounds of an unknown object contacting another unknown object. [REDACTED] later provided me the recording, which was transferred to a (E3) CD.

Officers Shaheed and Crockett arrived on scene to assist in my investigation.

Officer Mathiesen and I made contact with a male occupant of unit 622, later identified as (B1) Delwin Blackman. Blackman answered the door shirtless and appeared to be sweating. Blackman stated he and his girlfriend, (RV1) [REDACTED], lived in the apartment. I instructed Blackman to retrieve [REDACTED] from the bedroom, and he complied.

At this time, I heard the sound of a female crying in a distraught manner and instructed [REDACTED] to exit the room and speak to me. I observed [REDACTED] to have visible redness to the left side of her face and possible swelling to her left eye.

At this time, Officers Crockett and Mathiesen placed Blackman in handcuffs and detained him in the living room area of the apartment.

[REDACTED] was crying and distraught as I attempted to obtain her contact information. [REDACTED] could not slow her breath and continuously stated she did not know what happened. [REDACTED] could not bring herself to initially answer my questions and instead stated she was scared multiple times. I was able to calm [REDACTED] down and stated that Blackman and herself had attended a Christmas party where they both drank multiple alcoholic beverages. [REDACTED] and Blackman returned home after the party, where Blackman began to argue with [REDACTED] about unknown relationship issues over a year ago.

At this point in the argument, [REDACTED] and Blackman are located in the bedroom when [REDACTED] stated, "he just started beating me". [REDACTED] again became very distraught when she explained that she was hit "so many times" with open hands. [REDACTED] did not recall what hands she was hit with and began to cry uncontrollably. [REDACTED] would not answer any further questions regarding the incident details, instead she would tell me that she wanted Blackman to be safe and to have his lawyer.

[REDACTED] did not appear to have any visible markings indicative with strangulation or Blackman holding her down impeding her movement. [REDACTED] sustained multiple small cuts to the left cheek and apparently sustained swelling to the left eye. SFFD M67 responded to the scene to treat [REDACTED].

Officer Mathiesen mirandized Blackman, who stated the following in summary:

Blackman and [REDACTED] returned home from a Christmas party at an unknown time. [REDACTED] became upset over an unknown matter in the elevator to the 6th floor. [REDACTED] and Blackman engaged in a heated argument as they approached their apartment door. Blackman stated that [REDACTED] entered the apartment and went to the bedroom to sleep. Blackman remained in the living room and only entered the bedroom to hug [REDACTED] in attempts to console her. Blackman stated he began to fall asleep on the couch as police arrived at the apartment door.

Blackman had no visible injuries on his person and refused all medical treatment.

Officer Mathiesen conducted a computer query of Blackman, with negative results.

I searched the bedroom area of the apartment, where [REDACTED] stated the incident took place and located (2) (E4) bloody pillowcases. I seized the pillowcases and secured them in the trunk area of our patrol car.

Officer Mathiesen and took a total of 7 photos of the scene, Blackman and [REDACTED].

Based on my on scene investigation, I determined there was sufficient probable cause to place Blackman under arrest for felony domestic violence (N/W 273.5 PC) per the approval of Sgt Espinoza #525.

Veronica #299 of CWB confirmed that Blackman had no active warrants.

It should be noted that throughout the course of my investigation [REDACTED] became very uncooperative and recanted her initial statement "nothing happened". [REDACTED] advised me multiple times as I attempted to provide her with SFPD follow up forms that she did not want Blackman to go to jail.

I provided [REDACTED] with a SFPD follow up form, Marsys Card, Victim of Crimes form, and a Domestic Violence referral card.

Blackman was transported to CJ1 by Officers Shaheed and Crockett, where he was booked.

[REDACTED] was transported to CPMC VanNess to be treated for her injuries.

At Southern Station, I proceeded to call Commissioner Taply who granted an (E2) Emergency Protective Order against Blackman. Officer Mathiesen and I later served both [REDACTED] and Blackman the EPOs, and both understood the terms.

Officer Mathiesen completed (3) (E1) Domestic Violence forms.

All evidence was booked, uploaded, and attached to this report.
